IMPORTANT INSTRUCTIONS FOR CLASS I PROVISIONALLY SELECTED CANDIDATES

- (1) Admission is subject to production of relevant documents and correctness of the same.
- (2) Parent along with student can visit the Vidyalaya on any working Day during the school hours.
- (3) Admission Form will be given after thorough scrutiny of all relevant documents in Original
- (4) The following documents are to be submitted at the time of admission:
 - (a) Registration Form as submitted to OLA Portal
 - (b) Admission Form duly Filled.
 - (c) Date of Birth Certificate in Form 5
 - (d) Proof of Residence issued by competent Authority in case of candidates selected under RTE. (Right To Education)
 - (e) Caste Certificate in the name of the student (If Applicable)
 - (f) Caste certificate of Father in case caste certificate of Candidate is not available, with a declaration from the parent to produce the certificate in the name of the student within one month.
 - (g) EWS/BPL certificate of Parent issued by the competent authority (If Applicable).
 - (h) Certificate from Civil surgeon in case of Differently Abled.
 - (i) Joint Affidavit of Parents in the prescribed proforma (Available on our Vidyalaya website and also OLA Portal) incase selected under "Single Girl Child" (SGC), duly signed by First Class Judicial Magistrate.
 - (j) Aadhaar Card of the Candidate
 - (k) Service Certificate as given in the OLA portal signed by the DDO/ Competent Authority (For Selected candidates under Service Category from Cat-I to Cat-IV) with Office Seal Clearly visible.
 - (l) Certificate clearly indicating the details of transfers of the Father/Mother in the prescribed proforma (as given in the OLA portal) and duly signed by the competent authority to prove your claim as given in the OLA registration form.
 - (m) Self-Declaration by the Parent regarding the correctness/Authenticity of Information given in the Admission Form (Proforma Available on our website <https://siddipet.kvs.ac.in>)
- (5) One Xerox copy of each document to be submitted after verification of the Original.
- (6) Payment of Fees:
 - (a) No fee is applicable for candidates selected under RTE (For Parents having no fee reimbursement only).
 - (b) For all other Candidates:
Admission Fee of INR 25/- (Twenty-Five only)
Vidyalaya Vikas Nidhi INR 1500/- (One Thousand Five Hundred only) for the first Quarter-April-June 2021.
 - (c) Fee Applicable is to be paid through online mode only after allotting the Unique Id to the candidate, on UBI KVS Fee Portal.
- (7) Last date for admission is 28.06.2021.
- (8) The studies of class I students will commence from 01.07.2021 either ONLINE or OFFLINE depending upon the instructions from KVS (HQ) and the Education Department of the State of Telangana.
